#### **Clerking Update**

#### Safeguarding Update

- 15 Day Rapid Review Chapter 4 of the above sets out statutory guidance for the new arrangements – a learning process to help quicken the serious case review process.

#### Horizon Scanning

Ofsted – latest from Amanda Spielman, Chief Inspector of Schools: The emphasis of Ofsted inspections will "shift up the management structure," but lesson observations will continue because teachers want them, Amanda Spielman has said. The Chief Inspector of Schools told Schools Week that although she wasn't pledging "in absolute terms" that inspectors will spend less time in lessons, schools should see the "weighting" of involvement.. read more here: https://tinyurl.com/y8rowpu9

Education Secretary Damian Hinds has vowed to take action on exclusions once Edward Timpson's review has concluded, saying he would not rule out legislation to ensure more accountability for schools that permanently exclude children and place them in alternative provision. The NGA has proposed to the DfE that there is a fourth Core Function of Governance – 'ensuring effective engagement with stakeholders' As you know, stakeholder views are a statutory responsibility but this goes a little further. It will be interesting to see if this is included in the next update of the Governance Handbook.

- Funding is the biggest issue for governing boards. Only half of respondents said that they were balancing income and expenditure with almost a third drawing on reserves. 75% of those drawing on reserves said these would be exhausted within two years.
- High needs funding is a big concern, with 74% of respondents saying they disagree that current funding is sufficient.
- Almost half of schools covered by the survey are providing additional services for families in need, including washing school uniforms, meals outside of term time, food banks and emergency loans. 38% of schools are providing financial support with purchasing school uniforms.
- The time commitment involved in governing roles is a potential barrier to some volunteers taking on or continuing governance roles, particularly when it comes to stepping up to chair.

## Regional Schools Commissioner, DfE

John Edwards, Regional Schools Commissioner, attended the NGA's East Midlands Regional Conference held on 29 September 2018. If you would like to receive a copy of his presentation or the workshop on SEND, please let Jill know.

Some of his key messages included:

- How effective governance raises standards confident and strategic leadership; leads the transition from vision to plan to delivery; holds itself and the leadership to account; uses data to anticipate challenges related to performance, financial sustainability and risk and committed to self-evaluation and recognises the benefit of peer challenge.
- He confirmed that the existing floor and coasting standards will remain in place.
- The DfE are improving their school improvement pages on GOV.UK by introducing a new section dedicated to school improvement support which schools can access.
